

Workshop with SOVVA & SAGARA Gram Panchayat Leaders to build Support Services for Coffee & Spices

Venue: Ushodaya Resorts, Araku Valley **Date:** 2nd & 3rd November2021

CONTEXT OF THE WORKSHOP

Sovva and Sagara GPs have been selected for the promotion of Natural Farming, DIMSA FPO was formed by the Sanjeevini NGO which is being used as a platform to network with various institutions for the promotion of Natural Farming. WASSAN took initiative through this FPO to implement the NF activities in GPs. The above 2 GPs have Rythubarosa Kendras (RBKs) which are serving a total of 39 habitations covering 2000 families. The major tribal communities are Konda Dora, Kodhu, Kotia, Bagatha, NukaDora, Dulia, Valmiki, Paringa Poraja and Mali. Konda Dora, Nuka Dora, Kotia, Kodhu and Bagatha are predominant tribes and among them Kodhu are categorized under PVTG.

WASSAN and Sanjeevini have initiated the process and sensitized GPs to move towards Natural Farming. On 3rd and 4th August SOVVA Sarpanch invited the ward members of SOVVA for a meeting to discuss the feasibility of Natural farming in SOVVA GP. SOVVA GP leaders have agreed unanimously to promote Natural farming and they announced on 15th August as part of Independence celebrations that SOVVA farmers will move towards promotion of Natural farming named as SOVVA declaration. WASSAN has given an orientation to the volunteers who were provided by the ward members, since then the ward members along with their volunteers participated actively in the habitation wise landscape mapping and planning process.

We have realized that there are 2634 acres found in 21 habitations of SOVVA GP. Out of which the Podu lands are 738 acres, Mettu lands are 1226 acres, Lowlands/wetlands are 660acres. Coffee and Pepper grown in 567acres, Ginger covered in 210 acres, Turmeric 63 acres, Sweet Potato 215acres, Millets 294 acres, Rajma 114acres and vegetables grown in 194acres.

In the planning process we have observed that there was a huge gap in the production system of main crops like coffee, Pepper, Turmeric and Ginger etc. No knowledge on crop management and Natural farming practices etc. Postharvest issues are badly impacting on their produce in marketing.

Sanjeevini and FPO leaders & WASSAN felt that to have a workshop with subject matter specialists to seek inputs to incorporate in the planning process.

As per the above strategy, WASSAN and Sanjeevini organized a two-day workshop with SOVVA and Sagara leaders and farmers. Extension officers from the coffee board, horticulture department were joined.

OBJECTIVE OF THE WORKSHOP

The main objective of the workshop is to share the Sovva GP planning process to GP leaders and FPO members. Invite the Coffee & spice board, horticulture department to discuss more on the production system of Coffee, Pepper and Ginger and Turmeric for GP level planning with consent of respective Sarpanches.

The workshop was held on 2nd and 3rd November at Ushodaya Resorts, Araku valley.

FIRST DAY (2nd NOVEMBER 2021)

Mr. Devullu welcomed the participants, followed by a self-introduction. Mr Ashok Sovva Sarpanch has given a brief introduction and objective of the workshop and summarized by Sunny WN. Ward members have shared their experiences in Sovva mapping and planning exercises done in their respective villages.

Mr. Pavan and Narsinga had shared the process of SOVVA GP mapping exercise and discussed gaps and constraints in the planning process. They have shared the Malingavalasa village case study as an example and discussed the plans/ demands which came through the exercise. Few

activities like soil conservation, rock bunding, contour trenches and intensification of coffee, water plans and proposed works under NREGs etc.

Facilitators have flagged issues in promotion of natural farming and cost of production, low production, value addition and market prices etc.

The participants were divided into 4 groups to discuss issues in production systems of Coffee



and Pepper and Ginger and Turmeric crops. Facilitators have provided a chart paper for each group and asked them to write issues in seed/plantation, Intercultural operations, Crop protection, Harvest and post-harvest issues.

[A] GROUPS FORMED INTO CROP WISE:

Total participants were divided into 4 groups and each group listed issues and challenges in cultivation of Coffee, Pepper, Turmeric and Ginger.

[A] INPUTS FROM COFFEE BOARD

Mr Mohan Coffee extension inspector explained about the Package of practices to be followed for coffee and pepper. He also shared the kind of support system available from the coffee board etc.

He said that the Coffea arabica variety is being promoted widely in the Visakha agency. Coffee plant management is the main aspect to enhance the yield of coffee. He has shared what are practices to be followed to increase coffee production.

- Raising saplings in poly bags.
- A pit must be made at least 30 days before transplantation, farmers must dig a pit sized 1.5ft deep with the same width and filled with manure while planting.
- Curved roots to be cut down while planting.
- Best season for the plantation is June/July.
- After plantation, the plant's height must be monitored, cut the top portion of the

- plant at 2.5 to 3ft above ground level for the first 3 years and then regular pruning is to be done periodically.
- In sloppy lands contours are made to control soil erosion.
- Lime application to control stem borer is another important management practice.
- Plants require full shade so good shade to be maintained.
- Pepper plants to be planted at a distance of 100feet each.

Both the coffee board & the ITDA have supplied manual operated baby pulper machines to the tribal farmers on subsidy. As per Mr. Mohan the pulp machines will be useful for the small farmers who own below one acre of coffee but not for large farmers. A person can manually operate 500kg of cherries beyond that difficult for him/her. Community pulper may be useful for large farmers or a group of farmers.

Soil erosion is another issue that farmers raised in sloppy lands. Support is available for contour trenches and rock bunds. GPs to be explored to access support from NREGs.

Drying of parchment is another issue, tarpaulins are not much useful but cemented drying yards are more useful for this purpose. Farmers opined that drying yards are required for household level rather than community level. Land availability at household level may be constrained.



Mr.Peter has agreed to explore elevated cotton covered Tarpaulin sheets for drying of parchment.

Mr. Ravindra did a brainstorming exercise with Sagara Sarpanch Mr. Seetharam along with the farmers on things to be done for the promotion of Natural farming in the Sagara GP. Few ideas emerged towards establishment of micro entrepreneurship and access to tools which are important for the farmers in seasons etc.

SECOND DAY (3rd NOVEMBER 2021)

The first session started by sharing presentations made in groups. Mrs Padma Horticulture officer explained the kind of assistance available from the department for Turmeric, Ginger etc. She has highlighted land preparation and short duration varieties which are available from the department.

Mr Ravindra and Mr.Pavan facilitated the session on how to address these issues highlighted in the production system. They have done planning exercise as follows:



- Seeds/ plantation related issues.
- Land preparation
- Mechanization for intercultural operations and harvest and post-harvest
- Marketing issues and strategies etc.

A detailed action was prepared with several group discussions.

- After listening to the SOVVA GP planning process, the Sarpanch of Sagara GP requested to conduct the similar process in their GP and planned accordingly.
- Sovva and Sagara GP leaders and FPO members actively participated in the preparation of an action plan, particularly technology intervention to enhance crop productivity and value addition for better marketing opportunities.
- Sagara GP leader Mr. Seetharam had shared his experiences on coffee and pepper aggregation and collective marketing by farmers which they did in 10 years ago and discontinued due various internal reasons. Mr Seetharam expressed interest to do the similar aggregation of Pepper and Coffee for better marketing of coffee and pepper. They opined that a collection point and temporary storage land may be needed to create such a facility locally. Sagara GP took the responsibility to find the place to set up the collection point. Similarly planned to introduce technology which are available for Coffee & Pepper and Turmeric for production enhancement and value addition. There was a discussion on modification of tools for local convenience hence the WASSAN Foundation has agreed to help in this regard.

A small committee has been formed for Black Pepper aggregation and estimate the volume and preparation of the business plan. The committee members like Mr. Pandanna (FPO member), Mr. Seetharam (Sarpanch of Sagara GP), Mr. Ashok (Sarpanch of Sovva GP), Mr. Appalaswamy (Karakavalasa Ward Member) and Ms Gijivisha from WASSAN)

Mr Pavan has facilitated the session to prepare an action plan and categorized tasks and responsible persons against each activity. Key actors like GP leaders, FPO members, RYSS field cadre and WASSAN.
